



**Pittsburgh Water and Sewer Authority Water Treatment Plant Tour
Waiver/Release/Indemnity**

In consideration of me and/or my minor child being permitted to enter the premises of the Pittsburgh Water and Sewer Authority Water Treatment Plant I agree on behalf of myself/my minor child to all of the following:

- 1) I agree to comply with all applicable rules. I will listen carefully to all information and instructions given to me by my tour guides/Water Treatment Plant personnel.
- 2) I agree that I will stay on course in the tour. I will not deviate from the tour course set by the tour guides, at any time.
- 3) I agree that I will conduct myself in an orderly and respectful manner, at all times, while at the Water Treatment Plant.
- 4) I agree that I will not touch or operate any equipment in the Water Treatment Plant.
- 5) I agree that I will wear appropriate clothing and footwear for the tour.
- 6) I agree to NOT use my cell phone or have it out during the tour.
- 7) I agree to not take any photographs or recordings.
- 8) I understand that the Water Treatment Plant is an industrial facility with certain dangers inherent to such a facility, such as hazardous materials, chemicals, equipment, pipes, water, risk of falling or of items fallings and risks associated with high voltage electricity.
- 9) In consideration of being allowed to visit the Water Treatment Plant, I, HEREBY, VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY AND ALL RISK OF PERSONAL INJURY OR DEATH, PROPERTY DAMAGE, OR LOSS THAT MAY BE SUFFERED BY ME/MY MINOR CHILD DURING THE VISIT TO THE WATER TREATMENT PLANT, INCLUDING INJURY, DEATH OR DAMAGE CAUSED OR ALLEGED TO ARISE FROM THE NEGLIGENCE OF THE CITY OF PITTSBURGH, THE PITTSBURGH WATER AND SEWER AUTHORITY OR THEIR SUCCESSORS/ASSIGNS. I, VOLUNTARILY, ON BEHALF OF MYSELF/OR ON BEHALF OF MY MINOR CHILD, MY/MY CHILD'S HEIRS, ASSIGNS AND PERSONAL REPRESENTATIVES, RELEASE, INDEMNIFY AND HOLD HARMLESS THE CITY OF PITTSBURGH, THE PITTSBURGH WATER AND SEWER AUTHORITY, THEIR RESPECTIVE SUCCESSORS/ASSIGNS, ALONG WITH THEIR ELECTED OFFICIALS, OFFICERS, EMPLOYEES, AGENTS, REPRESENTATIVES, CONSULTANTS, VOLUNTEERS AND INDEPENDENT CONTRACTORS, FROM ANY AND ALL LIABILITY AND WAIVE THE RIGHT TO BRING ANY CLAIM OR LEGAL ACTION, WHATSOEVER, ARISING FROM THE MY/MY CHILD'S VISIT TO THE WATER TREATMENT PLANT.

If any part of this waiver/release/indemnity agreement is found to be unenforceable or invalid, that portion shall be severed, and the remainder shall remain in full effect.

I HAVE CAREFULLY READ, AND I FULLY UNDERSTAND THE WORDS AND THE LANGUAGE IN THIS AGREEMENT. I HAVE BEEN ADVISED OF THE POTENTIAL DANGERS THAT I MAY



ENCOUNTER WHEN I VISIT THE WATER TREATMENT PLANT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, ASSUMPTION OF RISK AND A WAIVER OF ALL CLAIMS BETWEEN MYSELF/MY MINOR CHILD AND THE CITY OF PITTSBURGH AND THE PITTSBURGH WATER AND SEWER AUTHORITY. I UNDERSTAND THAT THIS DOCUMENT IS BINDING ON ME, MY HEIRS, ASSIGNS and personal representatives and/my minor child. I sign this document of my own free will.
